



AudiCorporate – Purchaser Terms & Conditions

1. The AudiCorporate Program

The AudiCorporate Program is provided by Audi Australia Pty Ltd ACN 077 092 776 (“Audi”). Set out below are the terms and conditions governing the AudiCorporate Program.

2. The Privileges

The AudiCorporate Program Privileges are set out below.

Under the AudiCorporate Program, for each eligible new Audi vehicle or eligible demonstrator Audi vehicle (up to 4 months or 3,000km (whichever occurs first) from the warranty start date), employees of eligible companies will, subject to these terms and conditions, receive the following privileges:

- AudiCare A+ for the duration of the new car warranty.
- Complimentary scheduled servicing for 3 years or 45,000km (whichever occurs first) as per the manufacturer’s recommended scheduled servicing specification: (A) 15,000km / 12 months (whichever occurs first) (B) 30,000km / 24 months (whichever occurs first); and (C) 45,000km / 36 months (whichever occurs first). The maximum allowance for the final service is 39 months or 48,000km (whichever occurs first). It is the purchaser’s responsibility to present the vehicle for service at the afore-mentioned scheduled service intervals.
- If your vehicle is an A5, A6, A7, Q5, A8, Q7, R8 or any S or RS model, then for the duration of the AudiCorporate Program and subject to availability, an Audi loan vehicle will be provided to you on a complimentary basis during the period of servicing.
- For the duration of the AudiCorporate Program, free pick-up and drop-off of the vehicle to a maximum of 20km from the servicing Dealer when your Audi requires its scheduled service.
- Complimentary external washing of the vehicle when the car is being serviced for the duration of the AudiCorporate Program at the selling Dealer.
- Audi and its dealers will use reasonable commercial endeavours for the duration of the AudiCorporate Program to invite you to events sponsored by Audi.

3. Eligibility

A purchaser must identify himself/herself to an Audi dealer as an employee of an eligible AudiCorporate company whilst in the process of the purchase and when booking the vehicle in for a service.

A purchaser must supply to the dealer a current letter of employment (no older than six months) and a business card, security card or payslip (with company details). If the business card, security card or payslip are unavailable then this should be stated in the letter together with the reasons why.

4. How to get the Privileges

AudiCorporate Program Membership is available to any company that may be approved by Audi from time to time who agrees to purchase two Audi eligible vehicles per annum and has a minimum of five prestige vehicles under five years old.

Your authorised participating Audi dealer will be able to confirm the companies that are currently on the program or if an application is required. All applications for such companies to join the Program are reviewed by Audi who will determine in its absolute and unfettered discretion if the company is approved for inclusion in the Program.

5. Duration of Audi*Corporate* Program

- (a) Subject to the ensuing subparagraphs (b) and (c), the Audi*Corporate* Program is for a duration for 3 years from the date your vehicle warranty commences or 45,000kms (whichever occurs first) irrespective of whether the Audi*Corporate* Program Membership lapses or is terminated.
- (b) The privileges attaching to any Audi vehicle will terminate on sale or transfer of that vehicle by the first registered owner.
- (c) Notwithstanding subparagraph (b) above, Audi may terminate the Audi*Corporate* Program Membership at any time on written notice.

6. General

- (a) The purchaser acknowledges that Audi Dealers are not agents of Audi and have no right to bind or represent that they can bind Audi in any respect.
- (b) All purchases or leases by the purchaser of new Audi vehicles from approved participating Audi*Corporate* Program Dealers will be subject to that Dealer's normal terms and conditions of sale.
- (c) The privileges referred to are not available for used vehicles or ex-company fleet vehicles or dealer demonstrator vehicles that are over 4 months old from the warranty start date or over 3,000 Km (and any other vehicle notified by the Dealer or Audi from time to time as ineligible).
- (d) Any warranty or condition, including liability to the purchaser or its employees and agents, for any loss or claim related to the performance, failure to perform or delay in performance of Audi's obligations under these terms and conditions shall be excluded to the maximum extent permitted by law.
